

Village POA Meeting

Triangle Park

Meeting Minutes

6-10-2021

- Meeting was called to order at 6:32. Meeting was at the Triangle Park.
- Attending were Melissa Hamilton, Wilbur Oudman, Angel Bernahl, Loretta Bernahl, Ivan Whiteman, Aaron McKinney, Angela Abate, Mary Nolan, Justin Roseberry and Sarah Oudman.
- Minutes of the April 8 and May 13, 2021 meeting were approved.
- June 12 Event – 7 PM will be car registration and Campfire – Hot dogs and Smores. Traditions will provide beverages. There will be at least 3 judges. Prizes will be announced at 7:45. 1st place will be \$25 from Chesterton Toy, 2nd will receive \$15 from Bibi's and 3rd will get a \$10 certificate from Dog Daz. Angel and Shelly Williams will run the popcorn machine. Screen and sound set-up will be under the supervision of Robb Bernahl and Justin Roseberry.
- July 2 Event – Tables, chairs and tent have been reserved. We will grill hamburgers, hot dogs and brats. Some veggie burgers will also be done. POA will get 1 side (Cole slaw) and the rest of the sides will be potluck. The parade will begin at 7 pm at the flagpole. The Police and Fire Depts will lead the parade. Since we are not doing fireworks in the Village this year it was decided to make a \$1500 contribution to the Town of Burns Harbor Parks Dept if they are doing fireworks in conjunction with the town picnic in August.
- August 14 Event- We will be doing the derby cars. There will be 2 categories, Show and Race. The prizes will come from Chesterton Toys, Bibi's and Dog Daze.
- Landscaping – Melissa will check on the status of the contract with David's to tear out the bushes at the Gazebo.
- Triangle Park – Electrical upgrades are in the process of being completed. They are waiting on the streetlight and the template for the pole anchors. It was decided to place the electric outlet pedestals 6" above the grade. The concrete contractor declined the project so we are looking for a new contractor. The Little

Free Library will need to be removed during the pathway construction. It will be moved to Loretta Bernahl's house.

- Banners – Angel will follow up with Trinity to see where we stand with new banner designs.
- A question was raised about what to do with the old Village website. Brad Enslin may be able to give us some direction.
- Playground signs- Approval was given to purchase 4 directional signs for Playground at a cost of \$1238.
- Newsletter – Content for July is due June 25.
- Good of the Order- Residents should log noise complaints about the noise from Linde Air (formerly Praxair) to help identify the times when it is occurring. Melissa may be doing “Yoga in the Park” instructional classes in July. There was a question raised about pool memberships and the POA role in them. It was stated that the POA is not involved in the membership process and membership is between the homeowner and Traditions.
