Thank you all for attending our 1st POA meeting of 2023 on January 12. VARC Membership was voted upon at that meeting to nominate four new members. The results of that vote were determined to be invalid, as the number of votes per member were not verified by 1st American prior to the voting process. The POA Board is therefore calling for a re-vote, that will be managed entirely by 1st American. After VARC Membership is elected, the POA Board will appoint two voting members (with the Village Architect nominating the third). For now, the current VARC members are still Jeff Freeze, Nicole Hipp, and Justin Roseberry.
